Policing Survey 2016 - 2017 Results

The results of the latest phase of the Your View Counts survey which helps determine the policing priorities of communities throughout Scotland have been published. The survey has been live for nine months and has been completed by almost 19,000 people who live across Scotland.

Local priorities were identified as:

- -Anti-Social behaviour and disorder
- -Homes being broken into
- -Drug dealing / misuse
- -Violent crime
- -Child abuse including child sexual exploitation.

National priorities were identified as:

- -Counter terrorism / national security
- -Violent crime
- -Serious organised crime
- -Drug dealing / misuse
- -Child abuse including child sexual exploitation.

Hate Crime Awareness Week (27/03/2017 - 03/04/2017)

With over 300 Third Party Reporting Sites across the country, hate crime is a priority for Police Scotland and the campaign seeks to reinforce the message that prejudice based on sexual orientation, transgender identity, disability, racial or religious lines will not be tolerated. As victims don't always think a crime has been committed or thinking that ignoring the issue will make it go away, hate crime has become a widely unreported problem in Scotland. The campaign aims to provide a greater understanding to the public about what constitutes hate crime and how it can be reported. Hate crime is defined as a crime perceived as being motivated by malice or ill will towards a particular social group on the basis of their actual or presumed sexual orientation. transgender identity, disability, race or religion. Individuals who think targeting people who are different to them is acceptable behaviour are being forced to think again. Police Scotland is working with partner organisations to end such activity and bring perpetrators to justice. Ward Priorities

Indiscriminate parking

 You highlighted parking as a problem locally, the following was recorded regarding parking issues during the month of March 2017.

There has been one report of indiscriminate parking on West High Street during the month of March 2017. Further patrols will continue to be carried out and any vehicles reported or seen parked illegally will be dealt with robustly.

Speeding/Road Traffic

• Speeding is an issue that concerns you particularly in built up areas

Speed checks will continue to be carried out within the Borders at specific areas where there has been concern regarding excessive speed and highlighted accident hot spots. There have been no incidents of excessive speed highlighted in the month of March 2017.

Rural thefts

• Thefts from houses and farms particularly in more remote locations concerns you

There have been no recorded incidents of theft by housebreaking from commercial dwellings during the month of March 2017. However residents are encouraged to remain vigilant and report any suspicious activity.

30/03 - Fence damaged, Old School Place, Lauder, enquires ongoing.

Residents are encouraged to be vigilant and report any suspicious activity to Police Scotland. If possible ensure that your property and vehicles are securely locked and that all valuable equipment is out of sight!

Update from incident on the 29/01/2017 - Hare coursing on the Tollishill Estate, Lauder. The two males involved have appeared at court and pled guilty, a £600 fine and restrictions regarding their liberty have been imposed.
