SAFETY ADVICE IF YOU HAVE TO APPLY FOR A PAY DAY LOAN

On a regular basis, our officers from the Economic Crime Unit spot adverts from companies claiming to offer pay-day loans. However, many of these companies are not bona-fide. Fraudulent lending companies aim to look as legitimate as possible to lure potential victims in and scam them out of money or obtain their personal data by offering quick deposit loans to those in need. If you are in need of a pay day loan then please take great care when choosing a company to lend from. Do some research and if need be, check with the Financial Conduct Authority, who regulate all financial institutions.

HOW TO SPOT SUSPICIOUS EMAILS

The simple advice below describes how you can spot suspicious emails, and the steps you can take to ensure that you don't fall victim, both at work and home:

- Confirm details of the actual email address it came from, you can do this by hovering mouse over the senders email address.
- Many phishing emails have poor grammar, punctuation and spelling.
- Is the design and overall quality what would you'd expect from the organisation the email is supposed to come from?
- Is it addressed to you by name, or does it refer to 'valued customer', or 'friend', or 'colleague'? This can be a sign that the sender does not actually know you, and that it is part of a phishing scam.
- Does the email contain a veiled threat that asks you to act urgently, or

cause intrigue? Be suspicious of words like 'send these details within 24 hours' or 'you have been a victim of crime, click here immediately'.

- Look at the sender's name. Does it sound legitimate, or is it trying to mimic someone you know?
- If it sounds too good to be true, it probably is. It's most unlikely that someone will want to give you money, or give you access to a secret part of the Internet.

Your bank, or any other official source, should never ask you to supply personal information from an email.

Ward Priorities

Indiscriminate parking

You highlighted parking as a problem locally, the following was recorded regarding parking issues during the month of June 2019.

There have been no reports of indiscriminate parking during the month of June 2019. Routine patrols will continue to be carried out and any vehicles reported or seen parked illegally will be dealt with robustly.

Speeding/Road Traffic

Speeding is an issue that concerns you particularly in built up areas
