Ward Priorities

Indiscriminate parking

You highlighted parking as a problem locally, the following was recorded regarding parking issues during the month of September 2019.

There have been no reports of indiscriminate parking during the month of September 2019. Routine patrols will continue to be carried out and any vehicles reported or seen parked illegally will be dealt with robustly.

Speeding/Road Traffic
