Community Policing News – Leaderdale and Melrose

January provided us with some poor weather which made for difficult driving conditions due to the amount of black ice. This highlights the importance of ensuring vehicles are kept roadworthy and additional care is given when driving to prevent accidents. Officers have been involved in carrying out winter road safety checks where we would provide the following advice in cold weather conditions:

- Check that your tyres, brakes, windscreens, wiper blades and windows are free from defects, clean and clear
- Remove all snow from your vehicle before driving
- Drive to the road conditions; stopping distances will be affected by the weather
- Make sure your entire windscreen is clean, clear and not misted
- When roads are icy, drive at a slow speed in a high gear

Protecting most vulnerable

In January 2023 Police in the Scottish Borders attended and were involved with around ** mental health related calls, around ** missing person enquiries and approximately ** domestic related incidents.

Reducing Violence and Anti-Social Behaviour

On 24/01/2023 report of car driving around, black smoke issuing from exhaust in Dingleton Road area of Melrose. No further complaints made. No further details of car. No criminality detected.

Campaigns

Keep Safe Initiative

Primarily aimed at disabled members of the community helping to tackle disability hate crime, Keep Safe is a national network of over 800 safe places (including shops, libraries, pubs etc.) for anyone who may feel lost, scared or vulnerable when out in the community. All Scottish Borders Co-ops have signed up to the scheme with staff training, business packs and store signage being provided.

Divisional Domestic Abuse campaign

Regular social media posts highlighting local (DAAS) and national helpline contact details and reporting mechanisms

Ongoing engagement with main local employers to share campaign messages, information in relation to local support services and charities and prevention messages targeting perpetrators directly.

Rural

Scottish Borders Partnership against Rural Crime (SBPARC) the partnership continues to meet regularly to address local priority rural crime throughout the year.



 We continued to distribute free Selecta DNA forensic marking kits & signs and crime prevention advice to farmers and rural business. These can be requested by Farmers / Rural businesses using the <u>Contact Us Form</u> on the Police Scotland Website.



No Cold Calling Zones

- A new Zone has been set up in Eddleston covering 120 Houses Road signs and house-packs have been provided.
- Implementation work is ongoing with Bowden and Newtown St Boswells community councils for zones in these areas.

CAT Update:

ROAD SAFETY – SBCAT have continued with their winter safety campaign through January, carrying out road checks in various places in the Borders. SBCAT have issued 5 traffic tickets throughout the month. One person was also reported for driving with no insurance or mot and their partner with causing and permitting them to drive the car. Boy Racer



problems were also addressed in Galashiels, with one male being given a fixed penalty ticket for careless driving.

PARKING TICKETS – SBCAT have been carrying out high visibility patrols in Peebles, Kelso, Selkirk and Hawick, and addressing parking concerns there. 39 parking tickets were issued in January.

RURAL ACQUISITIVE CRIME – We continue to carry out static road checks in rural areas at all times of day to deter and detect rural acquisitive crime. 65 static checks were carried out throughout the Scottish Borders in January. SBCAT officers are also following up positive lines of enquiry into the theft of a vehicle from Blythe Bridge.

DRUG ENFORCEMENT – 6 drug search warrants were carried out in January in Galashiels and Kelso, with 4 of them providing positive results.

PROTECTING VULNERABLE PEOPLE — Part of the SBCAT role is to trace persons wanted on warrant. In January SBCAT traced and arrested one male who had been wanted for some time. We are also proactive in enforcing persons released on bail curfews, with 20 bail curfew checks carried out in January. SBCAT have also assisted with searching for missing persons in January.

ANTISOCIAL BEHAVIOUR – High visibility patrols have continued in Burnfoot Industrial Estate, Peebles, and at the Galashiels Interchange to address concerns at these locations. Two youths were issued warning letters for throwing snowballs at members of the public at the Interchange.
