Land North Of Allanbank House Manse Road Lauder Scottish Borders

Lauderdale Community Council (LCC) does not object to this application and has taken note of all the comments on the application. However there are some concerns on which we would like some clarification.

- 1. **The Lauder Sewage System**. LCC would like confirmation from Scottish Borders Council (SBC) and Scottish Environment Protection Agency (SEPA) that the current sewage system has the capacity to cope with the addition of 117 more houses.
- 2. **Lauder Primary School and Earlston High School**. LCC would like confirmation that the Primary School and the Secondary School has capacity to deal with the extra numbers of pupils.
- Lauder and Stow Health Centre and Borders General Hospital. LCC would like
 confirmation that the Health Centre and General Hospital has capacity to handle the
 extra number of patients.
- 4. **The Lauder Water Supply**. LCC would like assurance from SBC and Scottish Water that there will be capacity to manage the extra numbers.
- 5. **Playpark**. LCC note that there is no provision of a playpark for 117 new houses.
- 6. Buses. Does the Scottish Borders bus network have the capacity to cope with the increased numbers. Are there any plans for a bus to run from Earlston / Lauder to Stow?
- 7. **Additional path**. The suggestion from LCC is that a new path be laid at the north east corner to allow residents to walk to the local Coop, Bowling Green, Bus Stop in Edinburgh Road and the Lauderdale Hotel rather than taking a car.
- 8. **Increased traffic at the War Memorial junction with the A68**. Concern has been expressed on this.
